Questions 1-5: Experience and Motivation:

1. How and when did you first become involved in Cochrane and what has been your subsequent contribution to Cochrane's work (maximum 200 words)?

I have been an active member of the Cochrane Iberoamerican Network since 2015, participating regularly in regional meetings and Colloquia, and leading workshops for capacity building in systematic review production. I have coordinated or collaborated in research projects with Centres from Ecuador, Colombia, Spain, and Chile, which has allowed me to gain an understanding of the opportunities, needs and challenges faced by members of our region.

I have also authored several Cochrane reviews and I have served as an Editor for the Urology CRG for many years, which has allowed me to gain a profound understanding of the needs of authors and

editorial teams. My role as a clinically active family practitioner at an academic hospital helps me keep daily contact with healthcare professionals, students, and patients, and through that experience I am able to understand the importance of the knowledge translation activities carried out by Cochrane to make it "the home of evidence." Finally, I keep up-to-date with Cochrane's innovations and organisational news, including policies and regulations, discussing them regularly with other Centre Directors and analysing their implications for our Region.

2. What experience do you have serving as a member of a governing board, board of directors, management group or similar? This might be within a non- for-profit or charitable organization, or a hospital or University. I was appointed member of the Geographic Group Directors' (GGD) Executive in 2019. Since then, I have developed a broader insight into the global needs of Cochrane in setting up and supporting Geographic Centres round the world and the specific challenges for Centres in Lower-Middle Income Countries (LMIC). Furthermore, I learnt to understand the need for policy development in areas such as the benefits and expectations for the Geographic Groups, and supporting Centres in the development of sustainable plans with their host institutions.

I was also recently appointed Vice Chair of the Research Department of my institution. My role includes the coordination of research activity across our different areas, accountability of research activity, regulation of academic appointments and serving as an external advisor to the Institutional Review Board. This has provided me with a greater understanding of topics beyond research synthesis such as regulatory affairs and funding schemes. Moreover, this has also helped me recognise the opportunities and challenges for the development of Cochrane activities at academic institutions with competing research agendas.

3. Acting as a Board member requires a collaborative approach to decision- making, setting aside personal opinions and group affiliations and acting in the best interests of the charity. Please describe how you would fulfil this obligation, using examples from previous committee or other work (maximum 200 words).

Whereas I have to learnt to appreciate the needs of individual Cochrane members and groups, I also understand that trustees need to take challenging decisions for the development of the organisation considering Cochrane's best interest as a whole. For instance, in my role as GGD Executive I have provided feedback to applications from aspiring Centres of my own region applying the highest rigour in accordance with Cochrane standards. At the same time, I see that diversity in views and backgrounds across the Governing Board can help the implementation and adherence to such standards. For example, constructive feedback considering the context-specific challenges of aspiring Centres can help them meet Cochrane standards. I also appreciate that complementary views of my peers can help in the understanding of the implications of each decision made.

4. What do you think would make you an effective member of the Board (maximum 200 words)?

I have a profound understanding of Cochrane principles. I am personally fond of the first two principles regarding the collaborative nature of the organisation and the need for it to be built on the enthusiasm of individuals. I think that my connection to the world of healthcare, authors, editors, and geographic groups can help me provide insightful input to the discussions that take place at the Governing Board. I am also a good listener and I like to put forward creative and pragmatic proposals in situations where there is dissent or controversy, considering their possible impact on Cochrane's mission and image. I am highly eager to engage in debates on conflict of interest, open access, diversity, and equity, considering that these are some of the challenges that Cochrane, as most organisations, face in this century. Furthermore, while Cochrane is facing the COVID-19 pandemic with a strong response as a leader in evidence-informed healthcare, I am eager to discuss the implications on Cochrane's organisation and long-term plans, including the strategy beyond 2020.

5. What do you believe are the most important strategic challenges for Cochrane from 2020 onwards (maximum 200 words)?

I believe that the most important challenges include:

- Accessibility: whereas reviews are available in more than 100 countries by one-click access, Cochrane faces a challenge to reach full open access, as it was set up in Strategy 2020.
- Diversity and equity: while there is an increased presence of Cochrane groups across the world, there is also a need to expand the effective representation of Cochrane in LMIC countries, reducing linguistic and cultural barriers, facilitating knowledge translation and increasing the number of reviews that address high-priority topics identified by those countries. Moreover, a greater autonomy and decentralisation of its activities and initiatives, providing the adequate resources to do so, could expand the Cochrane's outreach as an international organisation.
- Methodological innovation: Cochrane is characterised by its continuous methodological innovation, reaching high standards for review production. This needs to be implemented in a way to ensure equity across the Cochrane community, while at the same time guaranteeing a continuous production of high-quality and prioritised reviews.
- Climate change and COVID-19: we have faced the cancellation of two consecutive Colloquia due to the social uprising in Chile and the pandemic, which has highlighted the need to think creatively of diverse ways to interact as an international community, reducing face-to-face interaction while at the same time, reducing carbon footprint.

6. Do you have experience of Knowledge Translation or science communication; and/or in widening access, participation, reach and impact of research?

Yes, I do. The greatest part of my work as an Associate Centre Director has been to disseminate Cochrane evidence for which I have devised different strategies in undergraduate medical education. My team and I currently teach over 450 medical students every year from two Universities:

- Using problem-based learning scenarios in which Cochrane reviews can provide input to promote the critical appraisal of primary research.
- Leading the local Cochrane-Wikipedia project, inserting the key messages of plain language summaries.
- Working with the local evidence-based medicine journal (*Evidencia*) in publishing *Patient Centred Evidence* portfolios written by students incorporating Cochraneevidence.

The main skills involved in these activities are those related to formal education planning, evidencebased practice, editorial experience, and leadership.

During the COVID-19 pandemic I have also been involved in disseminating Cochrane evidence:

- Providing summarised evidence (including Cochrane's emerging resources) for the development of local evidence-based recommendations for the treatment of COVID-19
- Being interviewed by local TV news programmes on controversies regarding the use of convalescent plasma and testing, for which I used Cochrane evidence; then I also coordinated a question and answer (Q&A) activity with the community (via Instagram Live).

The main skills involved in these activities included evidence synthesis and translation, use of social media and communication in plain language.

Besides my work with undergraduate medical students and the COVID-19 pandemic (see above), I have been called to participate in seminars regarding systematic reviews, evidence synthesis and uptake in several undergraduate and postgraduate programmes and national conferences of different specialties (Oncology, Dermatology and Family Medicine). Furthermore, I have worked closely with the Hospital associated to our University and their departments: General Surgery, Urology, Neurosurgery, Dermatology, Family Medicine, Psychiatry and Traumatology.

The competences involved in liaising with different stakeholders included interpersonal skills and tailored communication understanding the information needs of each target audience.

I have little experience in this area, however our Research Department is working in fostering open access throughout the research process and across research areas, including the registration and publication of protocols and policies surrounding data sharing, although this is in a preliminary phase.

Being part of Cochrane has tremendously helped my professional development. Cochrane's rigorous methods, quality, innovation, evolution as an organisation, and openness to a collaborative and enthusiastic work have built up in me throughout this time. This has helped me reflect upon and

address issues surrounding my professional activities outside Cochrane. Now I think that it is time to put these principles embedded in my skills to the service of the organization.
